

RESOLUTION

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weld County, acting as the Board of Equalization, that the evidence presented at the various hearings fully supported the value placed upon the Personal and Oil/Gas property as set forth on Exhibit "A." The assessment and valuation of property of the Weld County Assessor shall be, and hereby is, either approved, denied or adjusted to reflect those values shown on Exhibit "A."

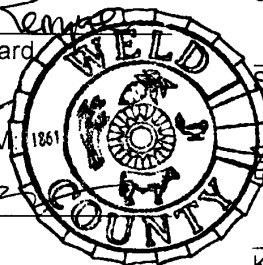
