SEEKING VOLUNTEER ADVISORY BOARD MEMBERS

The Weld County Commissioners are seeking Weld County residents interested in volunteering to serve on the: Housing Authority, Greeley-Weld County Airport Authority, Board of Adjustment, Noxious Weed Advisory Board, Fair Board, and the Board of Public Health.

The Greeley Housing Authority has a salaried executive director who is responsible for the daily operation of the authorities and reports to the authority monthly. Two of the seven board members are recommended by the County Commissioners for appointment by the Mayor of Greeley. Meetings are held the fourth Wednesday of each month at 4:30 p.m. The monthly time commitment is two hours. Applicants must live outside of Greeley city limits.

The Greeley-Weld County Airport Authority directs the organization and administration of the local airport. Meetings are held on the third Thursday of the month at 3:30 p.m., and the monthly time commitment is four hours. Applicants may live anywhere in Weld County.

The Board of Adjustment conducts hearings and decides appeals from decisions concerning the administration or enforcement of the Weld County Zoning Ordinance and interprets the location of zoning district boundaries and lot lines with respect to those boundaries. Meetings are the first Tuesday of the month, when called, at 11:00 a.m., and the time commitment is six hours annually. Applicants may live anywhere in Weld County.

The Noxious Weed Management Advisory Board advises county commissioners regarding integrated weed management on county and private property. Members must live within the unincorporated part of the county, and the time commitment is eight hours annually. This Board meets quarterly, the third Thursday, at 7:00 p.m. Applicants may live anywhere in Weld County.

The Fair Board conducts the Weld County Fair. The fair is an annual event held for the educational benefit of 4-H, Boy Scouts and Girl Scouts, and FFA, and to showcase the Weld County community. The board meets at 7:00 p.m. on the first Monday of each month. Extensive involvement during the fair is expected, and the monthly time commitment is four hours. Applications specific to this board are available at www.weldcountyfair.com.

The Board of Public Health approves bio-solid and individual sewage disposal system applications and holds hearings related to applications. Applicants for this position must live in School District RE-6 (east of 14th Avenue in Evans or Greeley) or in School District RE-7 (Kersey/Gill/Barnesville area). Meetings are held the fourth Tuesday of each month at 9:00 a.m. The time commitment is three hours monthly.
