

KEY ACCOMPLISHMENTS

Northern Colorado Construction Sector Partnership

As a regional effort, Larimer and Weld Counties launched the Construction Sector Partnership in Larimer County on Wednesday, December 4th. The industry discussion led to six (6) themes with various industry leaders signing up to take part in action teams. The Action Teams met in Weld County on January 31, 2020. Breakout conversations helped attendees understand the purpose of each theme. Although COVID-19 has hindered in-person meetings, the partnership leaders continued strong with virtual offerings. The New Way of Doing Business Committee hosted a conversation titled, "Navigating Through Economic Uncertainty" and the Perception Committee hosted a panel for job seekers focusing on careers in the industry and current employment opportunities.

Independent Skill Building Programs for Foster Care and Kinship Youth

The Chafee Foster Care Independent Living Program assists foster youth likely to remain in foster care until 18 years of age and youth who have left foster care because they attained 18 years of age, to make the transition from foster care to independent living. During the program year, the administration of the County's Chafee program moved under Employment Services. This provided an opportunity for foster care program alignment and enhancements with an existing Employment and Training Program.

PSI - Pillars of Successful Independence (PSI) - This existing program is funded by Colorado Works and engages foster and kinship placed youth to enhance four skill building areas: life and social skills, education, and employment. These skills prepare the youth for independence and emancipation. The PSI Program serves youth ages 13-1/2 through 15-years old.

Chafee - The Chafee program serves young adults who are in foster care placement, or after care, with the opportunity to learn independent living skills through fun and engaging workshops, socialization activities and one-on-one meetings. The Chafee Program serves youth ages 14 through 23-years old.

RISE - Resources for Independence, Success and Employment (RISE) - This new program was implemented during the program year to support young adults who were formally in foster care. The focus for this program is around housing, education, employment and financial readiness. The RISE Program serves youth ages 18 through 21-years old.

COVID-19 Response

Employment Services of Weld County (ESWC) quickly switched from an almost 100% in-person service model to a 100% virtual service model as an immediate response to the COVID-19 pandemic. As conditions allowed, services switched to a new hybrid model of virtual and in-person services. The impact to providing services to the community was limited and several best practices were observed and put into routine practice. These include virtual job fairs, one-on-one program orientations, increased programmatic accessibility of documents, newsletters for High School Equivalency learners and more. The Registration team within ESWC was greatly impacted and temporarily changed their service model entirely during the height of the pandemic, to accommodate the increased need for Unemployment Insurance assistance.

Additionally, the Workforce Development Board assisted with providing potentially life saving information to the 20% of Weld County's population that is non-English speaking. Led by board member, Lisa Taylor, Executive Director of the Immigrant and Refugee Center of Northern Colorado (IRCNOCO), resources were provided on COVID-19 safety procedures protocols in over 1,500 languages.
